E. PUBLIC COMMENT. Barbra Willard read a statement (attached) concerning the Spalding transfer station.

Damon Shea of C&S responded to prior statement regarding pickup of bins from Spalding transfer station. Stated that a procedure is in place for regular exchange of full for empty bins. Mr. Shea stated that bins would be in place prior to Memorial Day Weekend for the pine needle and green waste clean at Spalding. Please read this letter aloud as a Public Comment for the record, at the meeting on April 28, 2021.

As residents of the N. Eagle lake communities, we have roughly 1500 sewer hookups between Spalding, Bucks Bay and Stone communities.

Since January alone, 8 approx new buyers have closed in Spalding alone (at least 4 of those are full time residents). It is the expectation that full time residents, will be increasing as we have seen similar changes beginning in 2019.

Waste management's support in these communities has decreased as waste demand has increased and, we have been at breaking and closure points a lot of days (especially during summer) over the past 3 years.

### Specifically:

Stone Transfer Station closed down impacting that community and Bucks Bay (causing 20-34 round trip miles for those communities to come to Spalding).

Spalding Transfer Station's waste transfer station was never updated to accommodate the extra trash and in fact, waste drop off days were closed to 1 day a week (from 2).

Waste management then placed another stipulation on Spalding that unless both waste bins were full C&S couldn't be called for pickup which represented more gate closures.

There was also a period of where lack of staffing at Spalding impacted all three communities.

When long time Staff retired, replacements were not immediately sought.

The only backup staffing available, had to drive - (if they were available and not needed at a different location) from Susanville or Janesville which is an added cost in terms of mileage.

In the winter, roads were sometimes impassable and that closed the transfer station, because it could have been operated by someone locally but not by someone driving in from the valley.

Not communicating closures to the communities that have longer drives, or even communicating to Spalding residents about closures, was not coordinated at all.

If a primary person who lives in the Spalding community is out ill, having surgery or on vacation (as an example) having a backup within the Spalding community represents no real added cost to the Waste Management District other than hiring and a few days training? With the loss of Debbie Rivas' salary, stating "there is no money in the budget" isn't a true statement.

Other remote locations have backup why not Spalding?

Spalding currently has an applicant who is willing to be temporary backup why is that not being addressed?

The consequences of these decisions by waste management, have negatively impacted these communities for quite some time and now, the fire and logging roads are showing evidence of dumping again which will become a larger cost to the county to address.

The cost to the county in terms of tourism will become great again if our lakeside communities become trashy.

These communities need a commitment from this board, that our services will be improved by privatizing, and we need a commitment to the quick resolution of our current issues while waiting for a privatization decision.

- Have C&S begin picking up waste bins weekly OR
- Add a 3rd waste bin to the Spalding transfer station that the community can walk up too and throw trash in if the
  two drive up bins are too full.
- Add a temporary backup person at Spalding (as is normal in other areas).
- After these three things are done re-evaluate if summer tourism increases merit opening 2 days a week rather than 1 between May 1st and October 31st.

We do not want to see another contract negotiated with any Waste Management Company in which our communities problems are not resolved.

It is in fact is disturbing that these communities were not considered at all in this privatization process given that the majority of tourism revenues come from the lakes of the area, and we would ask that any waste contract considered be available to the public and discussed in open forum.

Having waste customers yelling and bullying gatekeepers because of things that are out of a gatekeepers control, is not acceptable under any circumstance.
