TUESDAY February 26, 2019 at 1:00 p.m.

- A. CALL TO ORDER. At 1:01 p.m. Chairman Ellis called the meeting to order.
- B. ROLL CALL OF BOARD OF DIRECTORS. Clerk of the Board Rivas called the roll. Chairman Ellis and Directors Albaugh, Gallagher, Moore and Stafford were present.
- C. AGENDA APPROVAL, ADDITIONS AND/OR DELETIONS. Director Gallagher motioned to approve the agenda as written. Director Stafford seconded. The motion was approved 5-0.
- D. PUBLIC COMMENT. Damon Shea, C&S Waste Solutions, reported winter operations are generally going well, contaminants are still being placed in recycling carts, Recycling Coordinator Katie Cyprian is continuing educating customers on recycling and will be conducting presentations at schools and the Susanville Indian Rancheria. Also, the C&S app has helped getting information out on holiday schedules, all refuse trucks in the fleet are up and running, and roll-off box service has slowed down.

#### E. REPORTS AND INFORMATION

- 2. Auditor's Report. Program Coordinator Phillips reported on the budget. The Authority has made appropriation adjustments due to dump truck repairs. Revenues are ahead of projections. Fund balances are good on the general ledger report. No action required nor taken.
- 3. Claims of Expenses December 4, 2018 to February 19, 2019.

  Program Coordinator Phillips noted expenses for Best Best & Kriger (gun range debris removal), Downtown Ford for purchase of a pickup, North State Environmental for groundwater monitoring services and the State Water Resources Control Board. No action taken nor required.
- 4. Staff Reports. Program Coordinator Phillips reported the Bass Hill Wildlife easement agreement is still under review and the fiscal year 2017/2018 audit by Price Paige is in progress. Staff has submitted a revised post-closure maintenance plan and gas monitoring for the Bieber Landfill which is currently being reviewed by CalRecycle. Similar documents are being created for Madeline and Ravendale landfills. Additionally, staff has submitted the off-road equipment diesel emissions document.

Program Coordinator Phillips advised Directors that Bass Hill Landfill will be accepting credit cards starting Friday, March 1<sup>st</sup>. Clerk of the Board Rivas noted LRSWMA is in the process of switching banks from Tri Counties to US Bank. Landfill Foreman Gillis updated the Board on Bass Hill Landfill and Westwood Transfer Station operations and noted Westwood TS will be closed Wednesday, March 27th due to heavy snow conditions.
